The granting of this licence is subject to the following conditions:

- 1) Eastern Dawn Sports (Pty) Ltd shall provide the Mpumalanga Economic Regulator guarantees as determined by the Mpumalanga Economic Regulator from time to time, for liabilities of Eastern Dawn Sports (Pty) Ltd in relation to betting levies payable and betting debt payable by Eastern Dawn Sports (Pty) Ltd. The guarantees shall be maintained at such levels as may be determined by the Mpumalanga Economic Regulator from time to time.
- 2) Eastern Dawn Sports (Pty) Ltd shall submit to the Mpumalanga Economic Regulator, periodically as stipulated by the Mpumalanga Economic Regulator from time to time, a deliverable report containing all information required in the format approved by the Mpumalanga Economic Regulator.
- 3) Eastern Dawn Sports (Pty) Ltd shall ensure that internal control procedures are submitted to the Mpumalanga Economic Regulator prior to commencement of operations and are adhered to.
- 4) Eastern Dawn Sports (Pty) Ltd shall on a continuous basis, satisfy the Mpumalanga Economic Regulator of sufficient measures taken to ensure that persons under the age of eighteen (18) years are not allowed access or to remain in the area where betting takes place, approved by the Mpumalanga Economic Regulator from time to time.
